**Preamble:**

Aparna Enterprises Limited ('Aparna' or 'the Company') covered under Section 135 of the Companies Act, 2013 which stipulates the provisions relating to Corporate Social Responsibilities for companies, notified on February 27, 2014 and became effective from April 1, 2014.

With the passage of the Companies Act, 2013 the mandate for corporate social responsibility (CSR) has been formally introduced to the dashboard of the Board of Indian companies. Aparna has responded positively and took a commitment to develop good CSR practices in the organization.

Aparna Enterprises Limited is a 25 years old company, committed in providing quality products and services for its customers. For Aparna, the Corporate Social Responsibility (CSR) is the Company's commitment to its stakeholders to create best integrated communities, built on consistent and sustainable practices addressing social and environmental causes. It is committed to contribute to the economic development while improving the quality of life of workforce and their families as well as of the community and society at large.

**Corporate Social Responsibility Policy:**

At Aparna, being a responsible corporate citizen is given utmost priority. The corporate Social Responsibility of the Company is discharged under the aegis of Aparna Novel Society for Welfare & Research – ANSWER (Registration No.862/07 Dt. 29.05.2007) a registered society. In today's increasingly dynamic and inter-connected world, a company and the society in which it operates are intrinsically and inseparably linked. Corporate Social Responsibility or CSR is a natural corollary of this symbiotic and co-dependent relationship. The new companies Act, 2013 seeks to cast a legal obligation on this responsibility by making CSR a binding commitment for prescribed companies. Aparna has been a conscientious corporate citizen since its establishment. Community development and social empowerment has been at the forefront of the company's social responsibility initiatives. The CSR activities of the company spanning a school, healthcare centre and old-age home among others has resulted in the establishment of world-class facilities unmatched in quality and reach. The company has constituted a Corporate Social Responsibility Committee for overseeing the Corporate Social Responsibility activities of the Company.

**A detailed report on the CSR initiatives and activities are given as below:**

- 1. Academy:** To tap young minds and channelize their focus and energy, academy was set up in the year 2007. The Academy follows the Telangana State curriculum and strives to impart free and quality education to underprivileged children. Applications for admission are scrutinized by the Social empowerment Department and eligible candidates are shortlisted. The Shortlisted candidates undergo a medical fitness test and their family backgrounds are analyzed to exclude false claims and protect the interests of genuine

beneficiaries. Thereafter, the final selection is made on admission, all the academic and related expenditure such as fees, books, food, transportation, and healthcare are borne by ANSWER. The Academy has now 50 students' strength and every year 15 to 20 new children are brought into the fold.

2. **ANSWER** imparts training in Computer education, music and tailoring etc.
3. **Hermitage:** During the year 2014, construction of a separate building commenced to provide shelter and assistance to disadvantaged members of the society. The hermitage is an abode for senior citizens and young widows. The objective is not only to provide shelter to them, but also to ensure that the residents are provided with all amenities necessary to lead a comfortable life. Rooms, library, a common TV room and internet access are some of the basic facilities planned for the residents. The Hermitage also provides round-the-clock medical support. Cultural activities and festivals will be a regular feature of life at the Hermitage. The young widows, respectfully called young mothers, provide with opportunities to complete their education and become self-reliant.
4. **Other Initiatives:** Several green initiatives are underway in the CSR Project areas. An entire campus was constructed with lot of plants and herbs planted and rainwater-harvesting methods implemented. Waste management is a priority and effective means are in place to process the waste generated. The campus is also a plastic free and a no-smoking area. Support is also extended by providing financial aid to needy and deserving students admitted to Higher education.

**CSR Contribution:** Effective from 2014-15, at least 2% of average profits of past three years should be expended on CSR activities in terms of the new Companies Act, 2013. The Company voluntarily meet substantial amount required for initiates taken up by ANSWER since inception. The Board of Directors has approved to utilize the minimum CSR amount in fiscal year 2015-16 in terms of the 2% criteria laid down under the Act. **Monitoring, Review and Evaluation:** Aparna will receive requests for funding of projects throughout the calendar year. The CSR committee will deliberate on the proposals and approve for implementation at its discretion.

Aparna representatives and /or ANSWER Society or such other entity will monitor the status of each project and will report its findings to the CSR committee periodically.

The concept of CSR is governed by Clause 135 of the Companies Act, 2013. The Act and Rules require companies to set-up a CSR committee consisting of their Board Members, including at least one independent director.
